Any motion not needing prior notice is in order from the floor under New Business. If you plan to make a motion, it is helpful to have a written copy of your motion for the Chairman. If your motion needs funding, please specify the fund where the money will come from in the motion. "Expenditures of the principal from the Operations Endowment Fund, or the Project Fund, require approval by a two-thirds vote of the church members present and voting at a membership meeting" (Church Bylaws, Article VII, Section 3, Page 13).
